 - Updated Evidence Base.
- b) Authorise the Chairman of the Parish Council, in consultation with the planning consultant, to make any further amendments to the above documents arising from this meeting, and any necessary minor editing amendments.
- c) Subject to completion of (a) and (b) above, subject to the latest National Planning Policy Guidance (NPPG) advice on consultation during the coronavirus pandemic and further discussions with the Local Planning Authority (Mid Sussex District Council), to arrange a period of public consultation under Regulation 14 lasting at least six weeks in order to bring the plan to the attention of people who live, work or carry on business in the parish, with detailed timing and arrangements to be discussed and agreed at a future meeting of the Parish Council.
